Resident Advocacy Day

Through the support of the chapter, I had the opportunity to attend the CMA/AAP-CA legislative day in Sacramento, CA this spring as part of my community pediatrics education. During the trip, I attended a speech and discussion from the only pediatrician elected to state congress, Dr. Richard Pan. He described the origin of his interest in public service and the pathway it took for him for him to become a congressman. One of the highlights of his career has been authoring the bill abolishing non-medical exemptions to immunization for school attendance which has now been passed into law. The following day we attended meetings with acting congressmen representing San Diego to educate and advocate for bills supported by the AAP including Proposition 56 paramount to funding medical and SB-501 attempting to regulate anesthesia provision in dental offices.

Although as active duty members we are nonpartisan and recluse ourselves from involvement in politics, this opportunity allowed me to learn about advocacy on a state and national level. Seeing how Senator Pan has been able to propose and pass a bill widely supported by the public and the AAP and which will make children safer was inspiring. I recognized the opportunity and responsibility that we as pediatricians (and pediatricians in training) have to educate not only our patients, but also the public and lawmakers. I look forward to continuing this important role in society, and I thank the chapter for the educational opportunity in my professional development.

HPV vaccination experience at the United States Air Force Academy (USAFA)

We work in USAFA's Cadet Medicine Clinic, which is equivalent to a student health center at a civilian college.

We have the advantage of an excellent electronic immunization tracking system (ASIMS), and with the entry of the Class of 2020, we began to transcribe our students' childhood immunization records into their ASIMS immunizations record. This gave us the opportunity to look at HPV completion rates in our student population. We worked with the ASIMS immunizations programmers to create a report of HPV status by class year. In August of 2016, we found that HPV completion rates for cadets were approximately 51% for women and 22% for men. Since the majority of our cadets are in the 18-22 year old age range, we wanted to explore their barriers to vaccination, and develop ways to improve our HPV vaccination coverage.

We know that the more common barriers to immunization include hesitancy on the part of the patient, lack of endorsement from primary care physicians, and lack of ready access to vaccination. We hypothesized the primary barrier to vaccination for our patients was our geographic separation from the immunization clinic at the 10th MDG. Cadet Medicine is a stand-alone clinic located in an annex to an academic building on the USAFA campus. We're approximately two miles from the main MDG, which serves the medical needs of the rest of the USAFA installation. In our clinic, we offer comprehensive primary care services, including adolescent medicine, sports medicine, and physical therapy, and we have in-house pharmacy, lab, and radiology. However, in the summer of 2016, we did not have a robust immunizations capability. We felt that the distance to the MDG immunization clinic, especially since cadets have very regimented schedules, and are not allowed cars until their junior year, presented the primary barrier to vaccination.

We requested expansion of our minimal cadet clinic vaccine capability, so we could offer HPV vaccine in the cadets' medical home, but due to administrative barriers, we were not able to do so. Instead, we instituted standardized counseling regarding HPV vaccination at every graduation physical. Graduation physicals are performed during junior year, by two experienced board-certified family practice physicians. During counseling, they explained the importance of the vaccine, and how to travel to the MDG to get it. However, despite perceived interest from the students, at the end of the graduation physical period, in April 2017, we found that our HPV completion rates were at 52% for women, and 22.4% for men.

With this data, we plan to request expansion of our immunization capability to include HPV vaccine. Since the Class of 2017 has graduated, and the Class of 2021 is now on campus, we will recalculate our baseline vaccination rate, and repeat the education process during graduation physicals. We'll follow up in April after graduation physicals are completed, to see if removing a geographic barrier to access had a better effect on HPV completion rates than did counseling alone.
